Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the governing board of Academy del Sol and the general public that the governing board of Academy del Sol will hold a meeting open to the public on the date and time and at the location set forth above.

Pursuant to A.R.S. § 38-431.03(A)(3), the Board may vote to convene in executive session, which will not be open to the public, for discussion or consultation for legal advice with the board's attorneys concerning any item on the agenda.

**This meeting will be held virtually only.** Information related to how members of the public may attend the meeting is provided above.

All items on this agenda are open for discussion and possible board action, including reports and action items.

*Members of the public will have no more than 3 minutes to speak. In addition, if there are a number of people who wish to speak about the same issue and who have the same viewpoint about that issue, the Board Chair may direct them to appoint a representative or representatives to speak for the entire group. The Board may not discuss or take legal action on items that are not specifically identified on the agenda but that are raised in Open Call. Matters raised during Open Call that are on the current Board agenda may be discussed and/or decided by the Board at the appropriate time on the agenda.*
